## NOTICE OF EXECUTIVE SESSION

The Board of School Trustees of Fort Wayne Community Schools will meet in Executive Session on Monday, November 7, 2011 at 5:30 p.m. in the Grile Administrative Center, 1200 S. Clinton Street for the following purpose/s in accordance with I.C. 5-14-1.5-6.1:

\_\_\_\_\_ Where authorized by federal or state statute.

For discussion of strategy with respect to:

\_\_\_\_\_ (A) collective bargaining;

\_\_\_\_\_ (B) initiation of litigation or litigation which is either pending or has been threatened specifically in writing;

\_\_\_\_\_ (C) the implementation of security systems; or

\_\_\_\_\_ (D) the purchase or lease of real property of the governing body up to the time a contract or option to purchase or lease is executed by the parties.

\_\_\_\_\_ To receive information about, and interview prospective employees.

With respect to any individual over whom the governing body has jurisdiction:

\_\_\_\_\_ (A) to receive information concerning the individual's alleged misconduct; and

\_\_\_\_\_ (B) to discuss, prior to any determination, that individual's status as an employee, student, or independent contractor who is a physician.

\_\_\_\_\_ To discuss before any placement decision an individual student's abilities, past performance, behavior, and needs.

  X   To discuss a job performance evaluation of individual employees. This subdivision does not apply to any discussion of the salary, compensation, or benefits of employees during a budget process.

When considering the appointment of a public official, to:

\_\_\_\_\_ (A) develop a list of prospective appointees;

\_\_\_\_\_ (B) consider applications; and

\_\_\_\_\_ (C) make one (1) initial exclusion of prospective appointees from further consideration.

\_\_\_\_\_ To train school board members with an outside consultant about the performance of their role as public officials.
